## Additional Proposals

### Academic Calendars – AUC 1

Academic Calendars for 2021-2022 and 2022-2023 were approved with amendments.

### Delay of Fall 2020 Advising and Registration Start Dates – AUC 2

- Move the first day of advising for the fall semester from October 19, 2020 to October 26, 2020.
- Move the first day of registration for the fall semester from November 9, 2020 to November 16, 2020.

With the significant number of different modalities that faculty and students are experiencing for the first time this fall, we would like to give faculty and departments more time to plan for the spring, as well as give students extra time to understand their experience with our different modalities. The delay of both advising and registration provides that additional time.

### Spring 2021 Academic Calendar Amendments – AUC 3

Extend the winter break (December 2020 – January 2021) by one week and remove the March spring break from the spring 2021 academic calendar. The spring semester class start date would move from January 19 to January 25. In addition, four non-consecutive Wellness Days are added to the spring semester.

### Change to Incomplete Policy for Fall 2020 – AUC 14

For fall 2020 in the response to the disruption of the face-to-face modality of instruction only, faculty may choose to grant an IN grade at their discretion without any specific requirement. Students will have until May 12, to complete their work and receive a grade; otherwise, the IN will convert to a grade of 0.0 at the end of the semester.

### Change in S/U Policy - AUC 24

- Change to the deadline for when students need to request to an S/U grade, from the add/drop deadline (TO) the deadline to withdraw from a course (W).
- Eliminate the restriction “only one course in each liberal arts and sciences cluster may be taken S/U” for all students starting at the university in the fall 2021.

### Recognition of Changes to Liberal Arts and Sciences Program Names – AUC 60

- The name of the “Liberal Arts and Sciences Program” has changed to the “General Education Program” in all current and future references, including in the name of the Program Area.
- The names of the three tiers of the new curriculum have been modified to:
  - Foundation: Foundations for Lifelong Learning
  - Exploration: Critical and Creative Thinking across the Disciplines
  - Integration: Advancing and Applying Liberal Arts and Sciences Learning

### Temporary Academic Recovery Readmission Option (TARRO) – AUC 81

Provide the first-time first-year students that were suspended after the fall 2020 semester an opportunity to return to the university in a quicker period than is established by the existing credit elimination and readmission policies if the student requests to be readmitted to the university for the fall 2021.
