AUC #01: Academic Calendars 2023 – 2024 and 2024 – 2025

Note: Student Affairs had friendly amendments that are listed on the AUC proposals webpage.

Sponsor: Last year we considered 2023-2024 as the second of the two academic calendars submitted for the AUC committee to review, and it was approved. We can still discuss and make changes if we feel before it goes the final time to the president. Also sponsor gave a brief summary of the contract guidelines to the committee.

Academic Calendar 2023 – 2024

This calendar has 158 instructional days for the academic year; Development Day and President’s Welcome are on two separate days, like they used to be; and there are reading days built in fall and spring.

Academic Calendar 2024 – 2025

This calendar has 157 instructional days for the academic year; and Development Day and President’s Welcome are on two separate days again.

Discussion: Some committee members felt that students who work over the weekend would not be able to prepare for finals, if their last day of class fell on the Friday before. Felt the reading day should be put on Friday and make the last day of classes on Thursday, May 8.

Another committee member had mentioned they felt the spring break was too early, feels it should be pushed back by a week later. Feels if that move is made, faculty may be able to still cover enough work before spring break.

Sponsor and registrar's office stated: Both academic years, week 9 is when spring break falls. If we moved it to week 10, then it would fall on the CTL Tuesday. Pushing spring break a week, would push advising a week, which will move registration by one week.

Another discussion was on the deficiency grade date and that the last day fell on a Friday. Some worried students will not check by the proper date and it may cause problems.

Deficiency grades are on the 7th week, and the registrar's office runs it that way to keep it consistent.

A committee member asked if we could move deficiency grade to the Monday after spring break? Having a deficiency grade before advising is also helpful because they can see where their advisees are not doing good and pick classes they should be taking. Maybe pushing it by a week would be beneficial too.

Sponsor stated that we should also check with the Financial Aid office and Student Success office about their policies for deficiency grades as well.

Committee member wondered should their be a friendly amendment made to change the deficiency grade due dates in both Spring 2024 and Spring 2025 to the Monday after spring break ends?

Committee members wanted to know if this discussion can be moved and continue this to December AUC meeting and work on fixing this.
